RWAS Press Application Terms and Conditions

These terms and conditions are for press applicants, photographers and videographers wishing to capture footage at RWAS Society Events (Smallholding and Countryside Festival, Royal Welsh Show, Winter Fair).

Who can apply for a Press Pass?

1. Only photographers, videographers and journalists who have a commission from a bona fide publication (print and/or digital) will be considered for a pass. The publication, commissioning editor, email address and phone number must be included on the application form and they may be contacted by the Royal Welsh Agricultural Society. Samples of published work may be requested.
2. Press or photography passes will not be allocated to advertising representatives.

Limit on Passes

3. Limits are imposed on the number of passes allocated to individual organisations and/or publications. Applications may not be met in full. Unless agreed otherwise, only one journalist and photographer/videographer will be issued with a pass per publication per day and no assistants are permitted without permission.
4. The number of allocated passes is limited, and all applications will be decided by members of the society's Marketing and Communications Committee. Previous allocation of a pass is no guarantee of a repeat allocation in the future.

Request for Images/Footage

5. In return for the allocation of a free press and photography/videography passes and the full use of the facilities of the press centre, the society would like permission to use up to a maximum of six of your photographs taken at the event within its annual journal and other publications, if required. Full acknowledgment and credit will be given to the photographer in these instances.

Filming, Livestreaming and Broadcasting

6. If intending to livestream, film or broadcast at an event, please seek permission ahead of the event by emailing the RWAS Marketing and Communications team at press@rwas.co.uk

Livestreaming will only be permitted from outside of the rings.

Insurance

7. All photographers/videographers must carry full public liability and third party liability insurance and by accepting these conditions indemnify the Royal Welsh Agricultural Society against all costs claims and other expenses that they may incur from any third party. All photographers/videographers are reminded that they enter the rings entirely at their own risk.

Access and Code of Conduct

8. Photographers wishing to enter the judging rings will be issued with an armband when registering with the press centre. This needs to be worn to gain access to the rings and at all times for identification purposes when in the rings. The armband must be returned at the end of the event. **Please indicate on your application form if you intend to enter the judging rings to take photos during the event.**
9. **Photographers and press badge holders are requested to make every effort to avoid obstructing the view of the public and to act respectfully to each other, the stewards and spectators at all times.** To avoid delaying proceedings and in a bid to minimise disruption, photographers must comply with the requests and instructions of the stewards.

Official RWAS broadcasters and photographers always have priority in the competition rings.

Please note, there will be stricter monitoring by stewards in the Main Ring and Horse Ring at the Royal Welsh Show.

Dress Code

10. Photographers are expected to dress smartly if wishing to enter the judging rings (No jeans, shorts, or casual clothing please).

Any photographer or press badge holders in breach of these conditions will have their pass removed, be asked to leave the grounds and will not be allocated a pass to future events.

Submission of the application form confirms acceptance of these Terms and Conditions.
