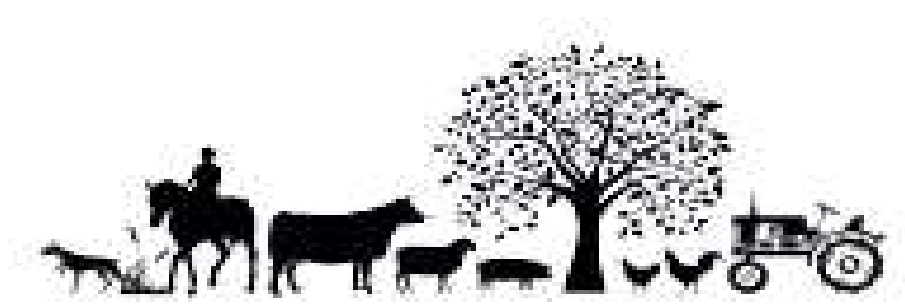

- Sheep Section – New stand-alone Blue Texel Section. We look forward to support from breeders.
- Boer Goat Section – Section open to CAE accredited goats only.
- Cattle Section – New Dairy Cattle Youngstock Section.

Breeds eligible to qualify for the section are as follows:- Albion, Jersey, Guernsey, Ayrshire, Dairy Shorthorn, Irish Moiled, Gloucester, Shetlands, Kerry, Dexter, Milking Devon, Northern Dairy Shorthorn, Original Population Dairy Shorthorn, Red Poll Cattle. (Breeds that are classed as dual purpose – exhibitors must decide which section they are entering them into. No one exhibit can be entered in two sections).

New Dairy Young Handler Section. We look forward to good support from breeders in both sections.

Closing date for entries - 3 April 2020



Please make sure you complete the correct form for the species you are exhibiting. Remember all sheep must be Non MV Accredited and exhibitors limited to two entries per class.



A separate entry form must be completed for each animal. There is no need to enter any special classes marked with an 'S' before the class number. There is no entry fee for special classes and no prize money is payable except where individually offered.



If you intend to stay on site in either a caravan, tent or use your stock vehicle as accommodation please indicate this clearly on the form. Please select only one option in order to receive the relevant pass.



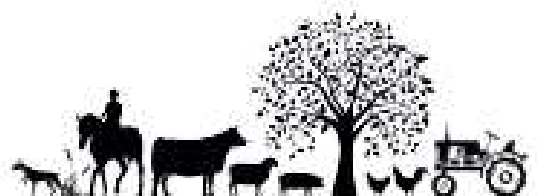
Kindly check the entry forms have been completed correctly before submitting. Any exhibitor, who is unable to attend the event after entering must inform the Society in writing by 1st May 2020, a refund will then be issued. Email notice of cancellations is accepted.



If the exhibitor is under 18 years of age then the official entry form has to be completed by a parent/guardian/agent who is over 18 years of age. Please note that whoever completes the form takes full responsibility for complying with all rules and regulations.
