- RWAS Sustainable Grass and Muck event committee are inviting tenders for the provision of a bar consisting of alcoholic and non alcoholic beverages
- Your tender must be accompanied with a food price list. Please state clearly what you food you'll be offering noting any food allergies.
- All equipment must be provided by the successful tenderer.
- The highest tender will not necessarily be accepted by the committee as prices charged to customers; presentation etc will also be taken into account.
- Catering area to be left in a tidy condition (with all rubbish removed). Removal and disposal of rubbish is the responsibility of successful tender not the committee
- During the event, the Caterer may only sell items as per tender as agreed by the committee and such items to be sold at prices submitted with tender.
- The successful tenderer must hold a valid licence to sell alcoholic beverages
- The successful tenderer to submit the tender amount in full to the office by Friday 5th of May
- The successful tenderer should bring their own water. No water supply will be available on site.
- Names of all employees on duty for the duration of the event, to be received by secretary on the day.
- Insurance and Proof of Policy for Employers Liability, Health & Safety Policy and a Risk Assessment must be sent to the secretary two weeks prior to the event.
- At least half of your staff must be Welsh Speakers (at least 50%)
- All equipment to be removed from the premises within 3 days after the event.
- .As this is a sustainable event would encourage you to use recyclable/biodegradable cups; .
- Sub-contracting the tender is not authorized, unless permitted by the committee.
- By entering this process the committee are not obliged to accept the highest or indeed any tender submitted.
